WHAT ELSE SHOULD I KNOW?

Audiological management is essential for children who have suspected hearing loss, a history of ear infections or other ear disorders. A multidisciplinary approach is usually considered and may include the Primary Care Provider, Otolaryngologist ("ENT") Physician, Audiologist, and Speech-Language Pathologist. These children should receive periodic hearing evaluations by a licensed audiologist even when they appear to be symptom-free. You should know that hearing assessments are required in most school districts at the onset of the school year for preschool and elementary students, and at least once during the winter months.

HEARING EVALUATIONS

A comprehensive hearing assessment can be completed at any age if there is suspicion that a hearing problem exists. Many modern methods can be used to accurately determine the hearing of a newborn, infant or child.

A case history and an otoscopic examination are essential. An audiological evaluation can help determine if a hearing loss exists in one or both ears at frequencies (pitches) that are critical to normal speech and language development, and if any identified hearing loss is conductive or sensorineural.

AUDITORY DEVELOPMENTAL & PROCESSING TESTING

Do any of the following

describe your child?

- 1. Problems hearing in noise or when others are talking.
- 2. Confuses directions or cannot follow commands.
- 3. Asks speakers to repeat says "What?" or "Huh?"
- 4. Problems paying attention to sounds.
- 5. Does not understand what is said when directly spoken to.

If you answered yes to any of these scenarios, your child may benefit from a comprehensive developmental or Auditory Processing testing assessment.
